the vast field of the relationships between orthodontics and posture.

Isabelle Gault explains for us how to integrate a succinct postural assessment into our clinical examinations and suggests what attitude we should adopt when we discover during the course of orthodontic treatment that one of our patients has a postural problem, especially when it is scoliosis.

Pierre-Henri Dupas *et al.* describe for us their approach to dealing with craniomandibular malfunctions in dentofacial orthopedics. After reviewing the etiology of the malady, they indicate its major clinical signs and show us how to go about making a postural diagnosis.

During the course of the discussion that Frédéric Marquet had with her Maryvonne Fournier provides us with a synthesis of her thinking and emphasizes the importance of myo-functional re-training exercises for the tongue within the framework of correcting the over-all posture of patients.

Because readers of articles devoted to clinical practice like to have them enriched with a varied iconography, the next two authors have added abundant illustrations to their presentations.
